2013 has been a year of change for WLCT. We started 2013 by finally moving into our new permanent home at the Town Farm. Along with our partners, The Trustees of Reservations (TTOR), we have successfully restored the farmhouse with your help. For the better part of the next century, the Town Farm will be managed by TTOR for all to enjoy.

In June, Peggy Stevens notified the Board that she would be moving on to another position in Virginia. Peggy's leadership over the past five years has been an incredible asset to the Trust. As our first full-time Executive Director, her dedication allowed for a much needed formalization and updating of many of the policies and procedures WLCT uses today and will continue well into the future. Herb Hadfield Conservation Area, Dunham's Brook Conservation Area, Forge Pond Conservation Area and The Let Conservation Area, just to name a few, are among the areas acquired and opened to the public under Peggy's leadership. We thank her and wish her and her husband Jonathan the very best in their future endeavors.

With Peggy's announcement, it was decided to form a search committee comprised of board members and advisors to search for our new Executive Director. Much of the summer was spent recruiting, researching and interviewing candidates.

He holds a Bachelors of Science from the University of Massachusetts Amherst in Natural Resources and was the Outreach and Stewardship Coordinator for the Harwich Conservation Trust on Cape Cod for the past five years. 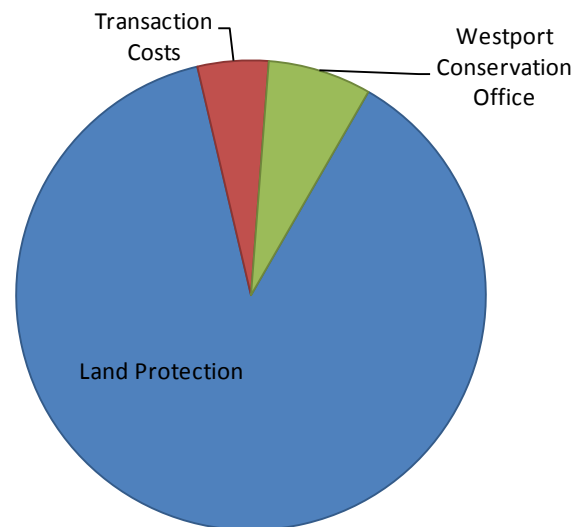

## The Westport Land Conservation Trust Restricted Funds 12/31/13

### **The Agricultural Preservation Fund**

**\$437,960.66**

A revolving fund to provide the Board of Directors with ready access to funds for the acquisition of agricultural land.

### **The Conservation Restriction Monitoring and Enforcement Fund**

**\$96,968.10**

A fund for monitoring, enforcement and legal defense related to the stewardship of conservation restrictions held by the Westport Land Conservation Trust.

### **The Dune Conservation Fund**

**\$28,246.28**

A fund restricted to maintenance of coastal dune areas owned by the Town of Westport through planting, fertilizing, anti-erosion barriers, and placement and maintenance of signs.



**Bread and Cheese Brook**

### **The Howland Memorial Stewardship Fund**

**\$129,724.35**

A fund in memory of Llewellyn and Sarah Howland to provide funding for the physical maintenance of properties in Westport which are owned in-fee by the Westport Land Conservation Trust.

### **The Richmond and Cockeyeast Ponds Fund**

**\$121,687.16**

Money restricted to land conservation projects within the Westport Harbor area and along the shores of the Richmond and Cockeyeast Ponds.

### **The West Branch Fund**

**\$23,312.69**

Money restricted to conservation-related expenses of land planning of the West Branch Association, Inc., a neighborhood association of twenty waterfront landowners along the east shore of the West Branch of the Westport River.
