A message from our President...

Dear WLCT Members:

Thank you for another wonderful year! 2016 brought continued success for the Westport Land Conservation Trust with the permanent protection of another 120 acres. Our efforts would not be possible without you. WLCT is fortunate to have highly devoted volunteers, passionate members, gracious donors and a great partner in the Town of Westport. Our stakeholders are the key to our success.

For forty-five years, WLCT has strived to protect the Town of Westport's distinct rural character and the wealth of natural resources. In 2016, we continued this work with the acquisition of the Richmond Pond Wildlife Sanctuary. The Fall River Diocese, who sold the property to WLCT, was essential to the success of this project. We thank the Diocese for their help to ensure the permanent protection of a unique coastal resource.

WLCT continued our support of the Angeline Brook Land Conservation Project, led by the Buzzards Bay Coalition, by taking ownership of five parcels totaling almost 89 acres. Angeline Brook is home to an abundant population of native sea-run brook trout and one of the few thriving populations left in New England. The conservation of this cold-water stream habitat is a prime example of preserving the best of Westport. WLCT also expanded the Herb Hadfield Conservation Area through the generous land donation from Andrea and Jose Ruiz.

Our land protection work continues, but we have expanded our efforts to offer a year-round assortment of public programs, a deeper focus on the stewardship of our land and expanded public access to conserved land. The 650 acres in our destination properties have 12 miles of trails for the public to enjoy. The annual Town Farm concert and Owl Show were a great success and we hope to see you there in the future!

On behalf of the WLCT Board of Directors, I want to thank you all for your generous support in 2016. I hope you continue to help us preserve land in Westport as future development pressure is a continued peril. Let's not let have asphalt be the last crop. Your continued assistance is vital to preserving Westport's rural character.





The Westport Land Conservation Trust Restricted Funds 12/31/16

The Agricultural Preservation Fund

\$438,457.00

A revolving fund to provide the Board of Directors with ready access to funds for the acquisition of agricultural land.

The Conservation Restriction Monitoring and Enforcement Fund


\$97,079.00

A fund for monitoring, enforcement and legal defense related to the stewardship of conservation restrictions held by the Westport Land Conservation Trust.

The Dune Conservation Fund

\$25,553.00

A fund restricted to maintenance of coastal dune areas owned by the Town of Westport through planting, fertilizing, anti-erosion barriers, and placement and maintenance of signs.



The Founders Stewardship Fund

\$222,336.00

A fund in memory of Llewellyn and Sarah Howland (formerly named Howland Stewardship Fund) to provide funding for the physical maintenance of properties in Westport which are owned in-fee by the Westport Land Conservation Trust.

The Richmond and Cockeast Ponds Fund

\$183,108.00

In 2016, the remaining funds were utilized to purchase the Richmond Pond Wildlife Sanctuary, which is consistent with the original stated purpose. Additional funds were raised for the purpose of assisting with stewardship and acquisition projects in the Acoaxet area. Both principal and interest of the fund are expendable. The Acoaxet area encompasses all lands south of Cross Road in Westport Harbor, MA.

The West Branch Fund

\$23,339.00

Money restricted to conservation-related expenses of land planning of the West Branch Association, Inc., a neighborhood association of twenty waterfront landowners along the east shore of the West Branch of the Westport River.




